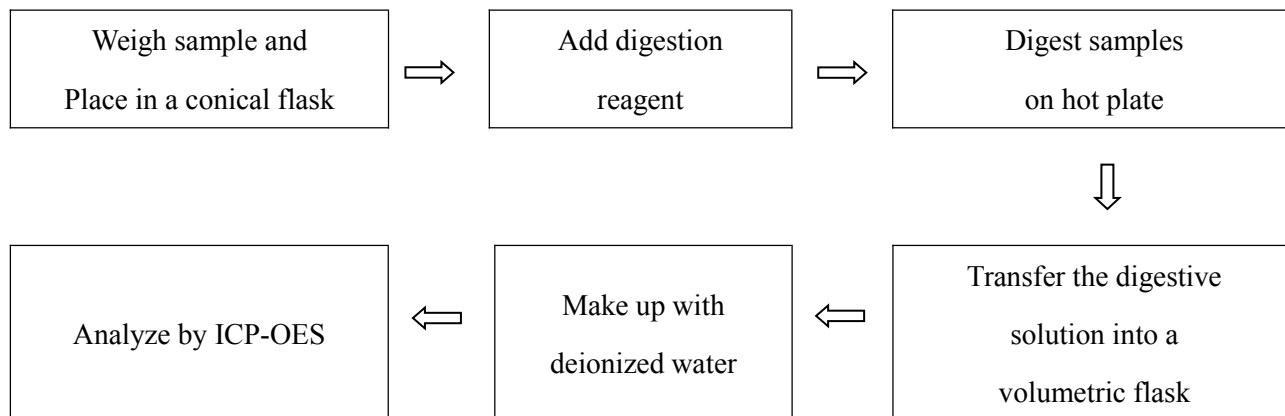

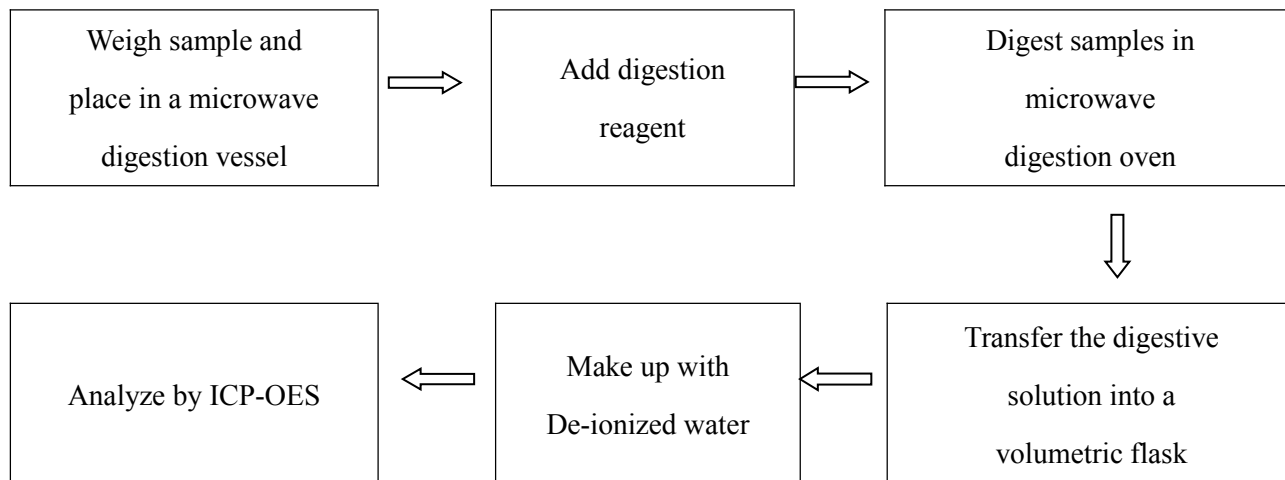

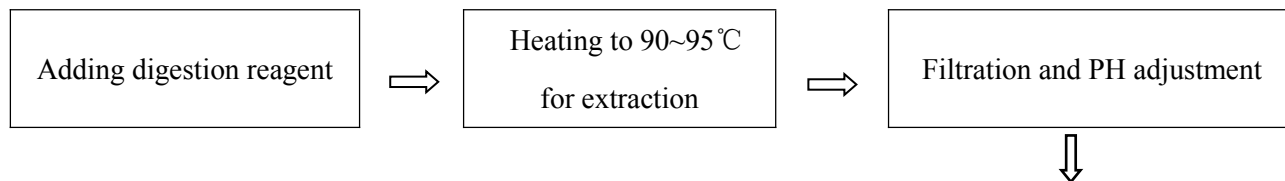


2. Test for Hg Content

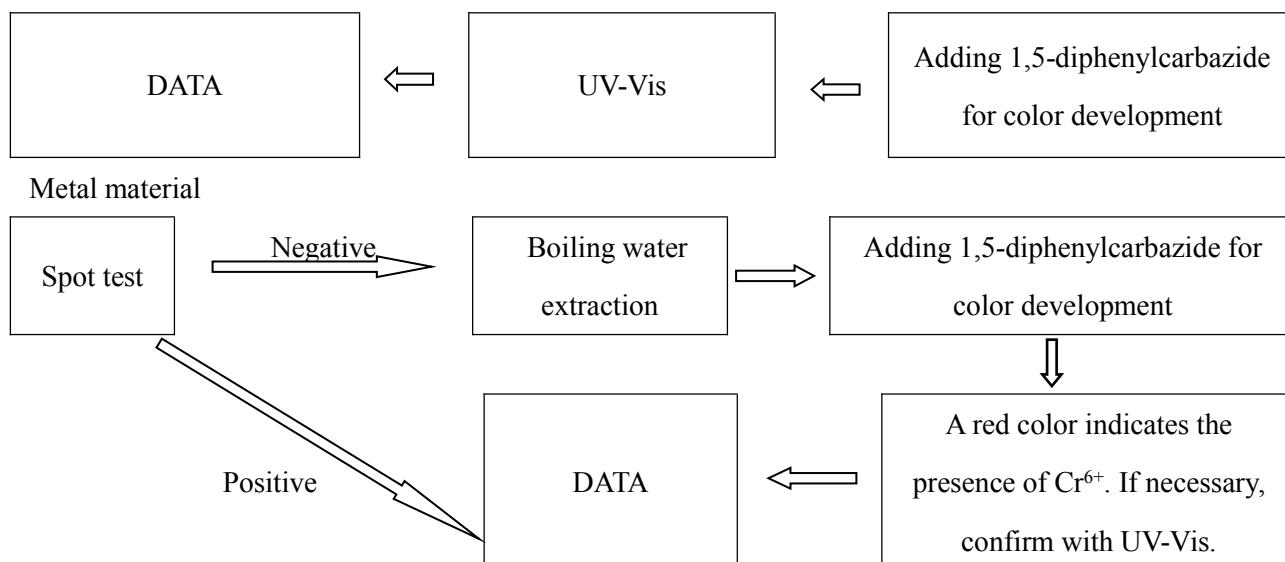

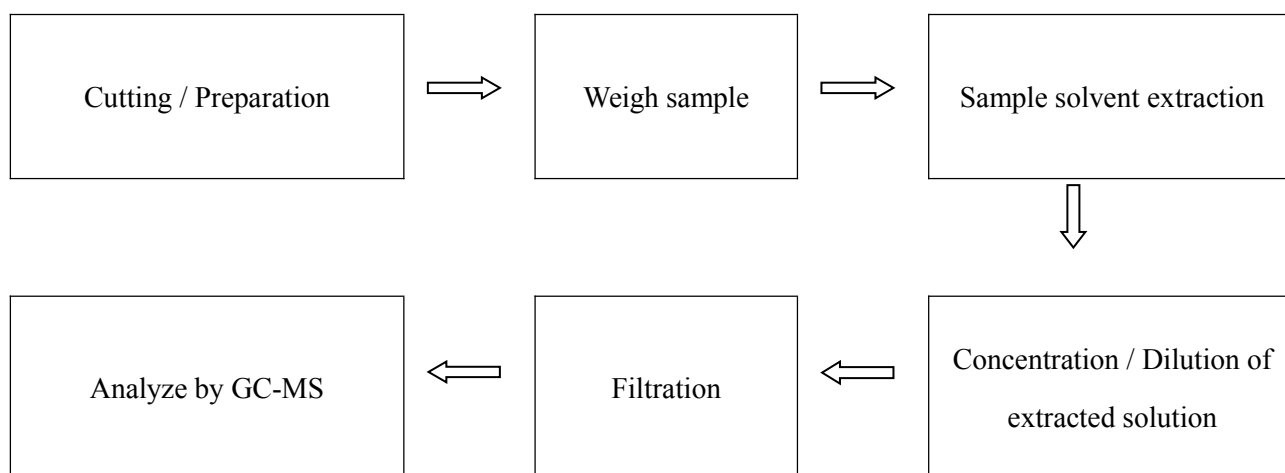

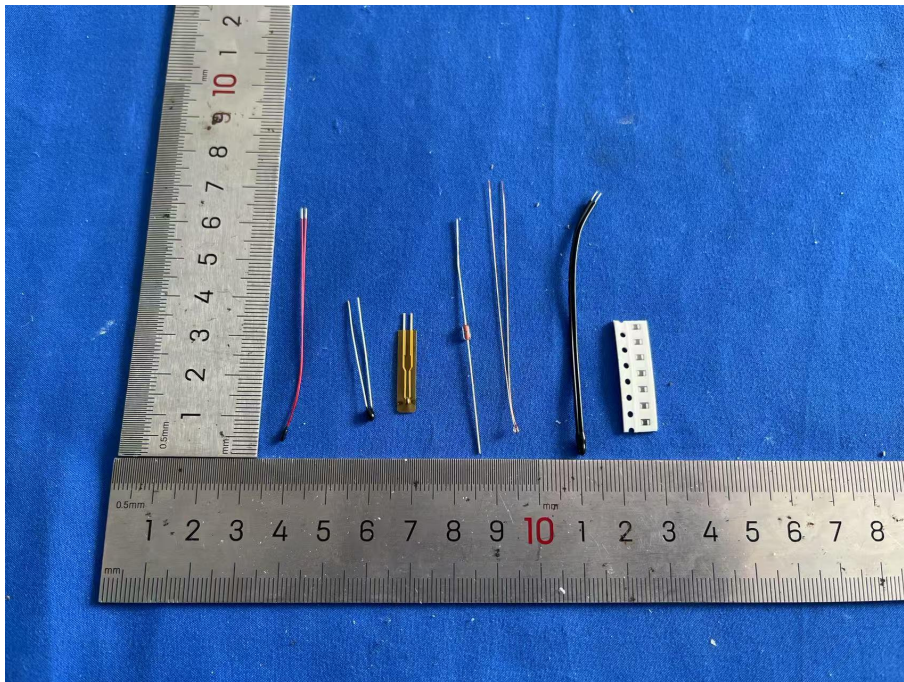
